TUITION RATES - The **Stewardship Tuition Rate** is offered to registered, active, supporting parishioners of St. Gregory the Great Parish who have made minimum contributions of \$14 per week, or \$728 per year in the Sunday envelope or through automatic debit for the **calendar year prior to registration**. Accounting provided to the school by St. Gregory the Great Parish office will determine the tuition rate for each family. **Qualification for the Stewardship Tuition Rate is reviewed and verified annually.**

Sibling Discount: The first child is the youngest child enrolled. 15% tuition discount is offered for the first sibling. 20% discount is offered for the second sibling. Tuition for the fourth child is calculated at \$1,000.

TUITION FINANCING OPTIONS - All tuition payments are payable through FACTS Tuition Management.

- Option #1: Payment in Full Plan due by July 1, 2024 (2% discount offered)
- Option #2: Semi-Annual Payment Plan 1st payment due July 1, 2024. 2nd payment due January, 2025
- Option #3: Monthly Payment Plan Choose a start date July 10th or July 20th, 2024, ending in April 2025

STUDENT REGISTRATION FEES

Registration fees are itemized and available for review on the school website. Registration fees will be posted on FACTS in February 2024 (returning students) and upon enrollment (new students).

FACTS TUITION MANAGEMENT

Returning Families:

St. Gregory the Great Catholic School partners with FACTS Tuition Management to process registration, tuition, and incidental billing charges. **Banking details are automatically renewed by FACTS annually.** Since registration fees are payable through FACTS, it is important to review your FACTS account now, and perform any edits that may be necessary for the 2024-2025 school year. **It is the responsibility of the parents to review their FACTS account information and make any necessary revisions/edits to banking details.**
