Requirements

- Stewardship Hours are required by all middle school students as part of the Religion curriculum to further their knowledge that service to others is what Christ called all of us to do. An emphasis on **community service** will be stressed as part of STGGCS stewardship.
- Household responsibilities, such as chores or babysitting a sibling will not count towards stewardship hours.
- Service performed during school hours will not count towards service hours unless pre-approved by religion teacher or principal.
- Each student must get pre-approval from their Religion teacher before **each** activity to ensure that the service project is approved. The only exceptions to teacher pre-approval are those listed on the *Stewardship Approved Organizations* sheet given out to students.
- Each middle school student must volunteer for at least 8 hours each trimester. Two of the 8 stewardship hours from each trimester must be served at St. Gregroy the Great Catholic Church (e.g., altar serving, donut ministry).
- Stewardship Hours must be participated in without compensation, monetary or any other type.
- Stewardship Hours for the 2024-2025 school year can begin June 10, 2024.
- In addition to serving the community, **a short reflection** (3-5 complete sentences) **and photo evidence, per activity**, will be required. This reflection will describe the impact the student made to the community regarding one of the Catholic Social Teaching themes.
- This form must be filled out completely, including all signatures, by the designated due date to receive credit.
